

The oldest commercial extant structure in downtown Corpus Christi is on the endangered list. Built in 1891 it has housed a hardware store, the post office, La Retama Library, the telegraph office, Bingham Drug Store, and remains intact under a stucco facade at 601 N. Mesquite.

NUECES COUNTY HISTORICAL SOCIETY

The Nueces County Historical Society was organized in November 1952 for the purpose of preserving the local heritage. Established in Judge Noah Kennedy's Office in the Nueces County Courthouse, a building constructed in 1914, its membership has always been open to the public. Dr. Floy Wise was elected the president, and the charter members were Wesley Agee, Aldine Brock Burton, Amelia Daimwood, Dr. William Hager, Dan Kilgore, and Bessie Stillwell.

The first complete narrative history of the local area was published in 1972 by the Nueces County Historical Society. The Society encourages young and adult members of the community to participate in research of local history and to publish individual historical works. The Society has published a newsletter since March 1970, containing historical data of significance and interest.

The group cooperates with the Nueces County

Historical Commission and Friends of the Courthouse,
Inc., in accomplishing restoration and preservation
projects. The Society meets, monthly, featuring programs
on local history. These meetings are always open to the
public, as are Society-sponsored field trips to historic
sites within a 150-mile radius of Corpus Christi.

Members of the Nueces County Historical Society assisted in the photographic research for Windsor Publication's Corpus Christi: History of a Texas Seaport. Monetarily, the Society contributed to the restoration of the 1880 Nuecestown School at Hilltop Community Center and the 28th District Courtroom Museum in the 1914 Nueces County Courthouse.

Special sesquecentennial projects were the "Texas Treasure's Benefit" co-sponsored with the Corpus Christi Museum Auxiliary to house the 1554 Shipwreck Artifacts and the Col. Henry Lawrence Kinney bronze sculpture for the Nucces County Courthouse Sculpture Garden. These two fund raising projects netted \$20,000.

The Nucces County Historical Society is the oldest continuously active non-profit preservation organization in our community.
