REMARKS BY COUNTY JUDGE ROBERT N. BARNES

"I made comments based on these facts, in part, that are from the minutes of the Commissioners Court."

"December 1, 1913, bids were received on the new courthouse and jail. Separate bids on general contract for jail equipment, plumbing and electrical and phones. Total about \$225,000."

"February, 1913, the county judge was authorized to have trees planted. Harvey L. Page was paid from fees."

"Quarterly payments to county commissioners for supervising roads in their precincts were \$100 each (this makes \$400 a year) plus they got \$3 per meeting. (I said that the Caller-Times editorial board would have probably liked these annual compensations for county commissioners for \$415 a year.)"

"March 18, 1814: Courthouse and jail bonds were sold to George Clark. (His descendants are still in the community, of course.) The commissioners court consisted of Walter Timon, county judge; T.M. Lawrence, C.C. Wright, J.T. Bartlett and W.H. Hull."

"Also, during this time the court submitted and the people voted a \$165,000 bond issue for what we would now call the Nueces Bay Causeway to what we now call Portland." (San Patricio)

"November, 1914: Familiar names in the General Election were James Ferguson, governor; W.P. Hobby, Lt. Gov. (BIll Hobby's daddy). John Garner, Congress (former Vice President Under Roosevelt); Archie Parr, state senator; Pat Dunn, state representative, and August Uehlinger, county clerk (Marion's late husband's father)."

"January, 1915: Bids were authorized for the removal of the old courthouses and jail on the site. (No Walberg, etc., apparently objected.)"

"February 1, 1915: Commissioners met with contractor to receive the new courthouse and jail, and the county judge was authorized to hire a janitor.

"February 19, 1915: A public reception was held in the new courthouse and jail. The commissioners court in 1915 was the same as above, except that J.C. Baldwin replaced W.H. Hull."

"Also, in February, 1915, the commissioners court authorized the purchase of a 1915 model 8' seven-passenger Cadillac and hired a chauffeur. (The editorial board would not have liked this!)."
